To be eligible to apply for relief you must supply evidence of loss of income which occurred after 18 March 2020.

- Contributions your business/NFP makes to the Weipa/Cape Community
- Efforts you made to minimise impacts and losses
- Other options payment plans, time extensions would they be more beneficial
- Your business's Business Continuity Plan
